USE AGREEMENT FOR SHERLOCK'S SCIENCE DISCOVERY CAMP

Sherlock's Science Discover Camp (SSDC) PO Box 927 Van, Texas 75790. This user agreement is effective _____ by and between SSDC and _____ (Group Sponsor)

1. **Services to be Provided/Dates.** SSDC agrees to provide the following described services to the Group Sponsor; _____. Group Sponsor desires the services on the following dates:

2. **Use of Services.** Group Sponsor intends to utilize the services to facilitate the science TEKS using outdoor activities. Group Sponsor has requested following:
 - a. _____ **day camp.** 9:00 AM to 1:30 PM
 - b. _____ **overnight camp** 9:00 AM to 1:30 PM following day, with overnight facilities being provided.
 - c. SSDC has not granted permission for any use of the Facilities other than as set forth above.
3. **Payment/Deposit.** Group Sponsor agrees to pay SSDC the amount of \$ _____ per Participant, with a guaranteed minimum number of ____ participants. The total guaranteed minimum payment is \$ _____. Should Group Sponsor experience additional participants, the payment will increase accordingly. The maximum number of participants will not exceed 200. Group Sponsor will submit a non-refundable deposit of 10% of the guaranteed minimum payment along with a signed copy of this agreement in order to reserve the requested dates. If two schools request the same dates, the school whose deposit we receive first will be given the dates. We will try our best to let you know on the website which dates are still available. Balance of the payment due, will be paid by the Group Sponsor upon arrival at facility. Group Sponsor will be responsible for all applicable state and local taxes on the payment.
4. **Participant Agreement/Insurance.** Group Sponsor will provide a signed SSDC Participant Agreement for each participant in the group. Prior to the beginning date of Group's use of the facilities, Group Sponsor will provide satisfactory proof of liability insurance coverage for all participants. Group Sponsor has the right to pass this on to the families of the participants, but must provide documentation.
5. **Guidelines.** Group Sponsor has been provided with a copy of the SSDC User Guidelines and Group Sponsor agrees to comply with and enforce such guidelines at all times during the Group's stay. Failure of Group Sponsor or individual participant to abide by the SSDC guidelines may result in dismissal from the camp program, with participant family and Group Sponsor being responsible for all costs of travel home.
6. **Cancellation/Refund Policy.** Group sponsor's cancellation of this Agreement for any reason more than 60 days prior to the beginning date of Group's intended

- use will result in forfeiture of Group's deposit. Group Sponsor's cancellation of this Agreement for any reason 60 days or less prior to the beginning date of Group's intended use will result in Group Sponsor's obligation to pay 75% of the guaranteed minimum payment set forth in #3 above, unless SSDC agrees to a reduced payment. (in SSDC sole discretion)
7. **Special Needs.** Should Group desire handicap space within the facilities, or any other any other special requests regarding the use of the facilities, such requests must be specifically set forth in Paragraph number 1 above. Should Group Sponsor learn subsequent to signing this Agreement that one or more of its participants may need special facilities or other accommodations due to disability, Group Sponsor should convey such a request no less than 7 days prior to the commencement of its beginning day of camp. Since the camp is being held at a facility that is ADA exempt, wheelchair accessibility is limited. Please contact us with your requests so we can see if accommodations can be made.
 8. **Damage to Facilities.** Group Sponsor agrees to reimburse Camp Deer Run for the actual costs incurred by Camp Deer Run in repairing or replacing any damaged or lost equipment or property belonging to Camp Deer Run as a result of Group's use of the facilities.
 9. **NO TOBACCO PRODUCTS OR USE OF ALCOHOL OR ILLEGAL DRUGS.** The use of tobacco products (smoking cigars, cigarettes, pipes, or smokeless tobacco) and using or having illegal drugs or alcohol is strictly prohibited at SSDC at all times.
 10. **Indemnity.** Group Sponsor agrees to release, indemnify, and hold harmless SSDC, its officers, agents, and employees for any and all claims causes of action, damages, losses, expenses, or costs resulting from any injury to the property of person of any participant in Group's use of the facilities, except as may be caused by the gross negligence of SSDC, its officers, agents, or employees.
 11. **Contacts.** Set forth below are the primary contacts of SSDC and Group Sponsor for purposes of this agreement. By signing below, each individual certifies that he or she has the requisite authority to bind SSDC or Group Sponsor to the terms of this Agreement.
 12. **Agreement Binding.** This agreement and the promises and obligations contained herein are binding and can not be modified except as may be agreed upon in writing by both parties.
